## DECLARATION TO CORRECT ASSIGNMENT

1. I, William J. Calore, am general counsel for Axletech International Holdings, LLC ("Owner"). The matters set forth in this declaration are based upon my personal knowledge, except where otherwise indicated, and if called as a witness I could and would testify competently thereto. I make this declaration to correct a typographical error in the Owner's citizenship for U.S. Trademark Registration No. 3,697,522 for "AXLETECH" (the "Trademark").
2. On June 6, 2008, a trademark application for the Trademark was filed. A true and correct copy of the application is attached hereto as Exhibit 1. There were two typographical errors made at the time of filing, one in the Owner's name, and another in the Owner's citizenship, whereby Owner was erroneously set forth as:

**AXLETECH INTERNATIONAL IP HOLDING, L.L.C., A LIMITED LIABILITY COMPANY  
LEGALLY ORGANIZED UNDER THE LAWS OF DELAWARE**

3. The registration certificate for the Trademark issued on October 20, 2009, listing the incorrect Owner name as set forth in paragraph 2 above. A true and correct copy of the registration certificate is attached hereto as Exhibit 2.
4. In an effort to correct the Owner's name, on January 19, 2015, Owner's prior counsel submitted an assignment consisting of a change of name (the "Assignment"), recorded at Reel/Frame 5455/0040. The Assignment correctly changed the Owner's name to the following:

**AXLETECH INTERNATIONAL IP HOLDINGS, LLC**

5. The Assignment corrected the typographical error in the spelling of Owner's name, but did not correct the Owner's citizenship, and incorrectly indicated that the citizenship was a "CORPORATION: DELAWARE". A true and correct copy of the Assignment is attached hereto as Exhibit 3.
6. The Owner has, since the filing of the application for the Trademark through present, been a limited liability company organized under the laws of the state of Michigan. A true and correct printout from the Michigan Secretary of State database showing Owner's name, entity type, and citizenship is attached hereto as Exhibit 4.
7. The Owner hereby requests correction of ownership to reflect the correct entity name, type, and citizenship, as set forth below:
