ASSIGNMENT

TOP OF THE ROCK (REGISTRATION NOS. 3,194,827, 3,268,693 AND 4,691,866) TOP OF THE ROCK NYC (REGISTRATION NO. 3,716,943)

THIS ASSIGNMENT is dated as of May 11 2016, by and between RCPI Landmark Properties, L.L.C., a Delaware limited liability company ("RCPI") and ROCKEFELLER GROUP, INC., a New York corporation ("RGI") (each a "Party" and together the "Parties").

WHEREAS, the Parties entered into an agreement dated November 10, 2005 (the "2005 Agreement") with respect to Trademark Application Serial Nos. 76,433,214 and 78,568,153, which matured into U.S. Registrations No. 3,268,693 for TOP OF THE ROCK and 3,716,943 for TOP OF THE ROCK NYC, respectively, whereby RCPI assigned those applications to RGI;

WHEREAS, the Parties entered into a separate agreement, also dated November 10, 2005, with respect to Trademark Application Serial No. 76,978,311, which matured into U.S. Registration No. 3,194,827 for TOP OF THE ROCK, whereby RCPI assigned this trademark registration to RGI;

WHEREAS, RGI obtained Registration No. 4,691,866 for TOP OF THE ROCK;

WHEREAS pursuant to the 2005 Agreement, RGI agreed to assign back all rights to Trademark Application Serial Nos. 76,433,214 and 78,568,153 to RCPI ten years after the effective date of the 2005 Agreement; and

WHEREAS, the Parties wish to execute this Assignment in furtherance of the 2005 Agreement,

NOW, THEREFORE, for and in consideration of the mutual agreements between the Parties and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, RGI does hereby assign to RCPI all right, title and interest in and to the TOP OF THE ROCK Registrations and TOP OF THE ROCK NYC Registration set forth in Exhibit A hereto, including all associated goodwill and the right to sue for past infringement. This assignment is without limitation and includes all rights which RGI has or may have anywhere in the world with respect to TOP OF THE ROCK and TOP OF THE ROCK NYC.

IN WITNESS WHEREOF, the Parties hereto have caused this Assignment to be executed as of the day and year first written above.
