**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of May 27, 2016 (this "Release"), is made by General Electric Company (as successor in interest by merger to General Electric Capital Corporation), as administrative agent ("Agent"), in favor of Gentle Communications, LLC, a Massachusetts limited liability company ("Grantor"), as follows:

W I T N E S S E T H

WHEREAS, pursuant to the Trademark Security Agreement, dated as of June 30, 2014 and recorded with the U.S. Patent and Trademark Office on June 30, 2014 at Reel/Frame No. 5311/0776 (the "Trademark Security Agreement"), the Grantor granted to Agent a security interest in certain collateral pledged by the Grantor described therein (collectively, the "Trademark Collateral"), including, without limitation, the United States trademark set forth on Schedule A attached hereto;

WHEREAS, the Grantor has requested that Agent release its security interest in, and retransfer and reassign to the Grantor all right, title and interest of the Agent in and to, the Trademark Collateral.

NOW, THEREFORE, Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby (a) terminates, cancels and releases the security interest in the Trademark Collateral, (b) retransfers and reassigns to the Grantor any right, title and interest of Agent in and to the Trademark Collateral, and (c) terminates the Trademark Security Agreement, except for any provisions therein that expressly survive such termination.

Agent agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of Agent's security interest in the Trademark Collateral (without recourse, representation or warranty and at Grantor's sole cost and expense).


