THE UNDERSIGNED CERTIFY THAT:


1. They are the president and secretary, respectively, of DISTINCTIVE APPLIANCES, INC., a California corporation.
2. Article One of the Articles of Incorporation of this corporation is amended to read in its entirety as follows:


The name of this corporation is **DACOR**.
