Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law (“**DGCL**”) and Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned surviving limited liability company submits the following Certificate of Merger for filing and DOES HEREBY CERTIFY AS FOLLOWS:

FIRST: The name and jurisdiction of formation or organization of each of the constituent entities to the merger (each, a “**Constituent Entity**”) is as follows:

SECOND: That an Agreement and Plan of Reorganization entered into as of May 13, 2013, as amended (the “**Merger Agreement**”), by and among DocuSign, Inc.(“**Parent**”), Bluebird Acquisition Corp. (“**Merger Sub One**”), Bluebird Merger Sub LLC (“**Merger Sub Two**”), Cartavi, Inc. (the “**Company**”), U.S. Bank National Association, (the “**Escrow Agent**”), Glenn Shimkus and Paul Koziarz (the “**Principal Stockholders**”), and Glenn Shimkus, as stockholder representative (the “**Stockholder Representative**”), has been approved, adopted, certified, executed and acknowledged by each of Parent, Merger Sub One, Merger Sub Two, the Company, the Escrow Agent, the Principal Stockholders and the Stockholder Representative in accordance with Sections 251 and 264 of the DGCL and Section 18-209 of the Delaware Limited Liability Company Act, as applicable.

THIRD: That Bluebird Merger Sub LLC shall be the surviving limited liability company of the merger (the “**Surviving Entity**”), and that upon effectiveness of this Certificate of Merger the name of the Surviving Entity shall herewith be changed to Cartavi, LLC.

FOURTH: That the Certificate of Formation of Bluebird Merger Sub LLC shall be the Certificate of Formation of the Surviving Entity; provided, however, that paragraph 1 of the Certificate of Formation shall be amended to read as follows:

“1. The name of the limited liability company is:

Cartavi, LLC”

FIFTH: That this Certificate of Merger shall become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware

SIXTH: That an executed copy of the Merger Agreement is on file at the principal place of business of the Surviving Entity at the following address: 1755 Park Street, Suite 200, Naperville, IL 60563.

SEVENTH: That a copy of the Merger Agreement will be furnished by the Surviving Entity, on request and without cost, to any member or stockholder of a Constituent Entity.
