NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT

THIS NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is made as of November 15, 2015 (the "Effective Date"), between Savory & Sage's, Inc., a California corporation with offices at 3800 N. Lomar Blvd., Suite 730-155, Austin, Texas 78758 ("Assignor"), and Delano Distributors, Inc., a Kansas corporation with offices at 1816 E Wasp Rd., Hutchinson, Kansas 67501 ("Assignee").

WHEREAS, Assignor began manufacturing and selling brines and marinades in or around 2008 and, in connection therewith, began using the trademark TURKEY BATH, as reflected in U.S. Trademark Reg. No. 3,795,929 ("the Trademark");

WHEREAS, Assignor sold, transferred and assigned its various business interests to Assignee in 2015, and Assignee has continued manufacturing and selling Assignor's brines and marinades and using the Trademark ever since;

WHEREAS, in order to effectuate Assignor's assignment to Assignee of its entire right, title and interests in and to the Trademark, Assignor is executing this instrument of assignment, *nunc pro tunc* as of November 15, 2015.

FOR GOOD AND VALUABLE CONSIDERATION, the sufficiency and receipt of which are hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee, Assignor's entire worldwide right, title and interest in and to the Trademark, including, without limitation, any and all common law rights thereto, the goodwill of the business symbolized thereby, and any and all U.S. trademark registrations and/or applications covering same, including but not limited to the U.S. trademark registration identified in the attached Exhibit A.

Together with Assignor's worldwide right, title and interest in and to the Trademark, as well as the goodwill of the business symbolized thereby, Assignor further assigns to Assignee the rights to police, monitor and enforce the Trademark and any associated registrations against any and all past infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) which may have occurred at any time in the unlimited past, up to the date of this present Assignment, together with any and all further privileges in the U.S. and throughout the world to use, own, enforce and/or register the Trademark.

Assignor hereby covenants and warrants that, with respect to the Trademark, it is possessed of all right, title and interest in and to the Trademark, its goodwill and registration, and it has the full right to convey the Trademark, its goodwill and registration by this instrument, free of any encumbrances. Assignor further covenants and warrants that no other agreement has been or will be executed in conflict herewith.

Assignor agrees to perform all affirmative acts which may be necessary or desirable to perfect the above-described transfer of rights, as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to the Trademark, its goodwill and registration.
