## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of May 18, 2016 (this "Release") is made by The Huntington National Bank, as Administrative Agent (the "Secured Party") under the Security Agreement dated December 20, 2012 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Granite Communities, LLC, Granite Homes, LLC, Inspire Communities, LLC (f/k/a Follett Investment Properties, LLC), Granite Willow Point, LLC, Granite Manvel Utilities, LLC, Manvel Utilities Limited Partnership, Granite Brownstown Land, LLC and each other entity which from time to time became a party thereto (collectively, the "Debtors"), and recorded in the records of the United States Patent and Trademark Office on December 28, 2012 at Reel 4930, Frame 0839.

WHEREAS, pursuant to the Security Agreement, the Debtors granted to the Secured Party a security interest in the Debtors' trademarks, including the trademarks listed on the attached Exhibit A (the "Trademarks").

WHEREAS, the Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to the Debtors; and (iii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
