**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of May 20, 2016, is made by **WELLS FARGO BANK, N.A.**, as successor agent (in such capacity, together with its successors and permitted assigns, the "**New Agent**") for the Secured Parties (as defined in the Credit Agreement referred to below), and **GENERAL ELECTRIC COMPANY** (as successor in interest by merger to GENERAL ELECTRIC CAPITAL CORPORATION) as former agent and current subagent for the Secured Parties ("**Subagent**" and, together with the New Agent, the "**Agents**"). Terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement, as applicable.

WHEREAS, in connection with that certain Amended and Restated Credit Agreement dated as of March 27, 2014 (as amended, restated, supplemented or otherwise modified to date, the "**Credit Agreement**"), by and among Columbus Manufacturing, Inc. (the "**Borrower**"), the other Credit Parties parties thereto, the Subagent, the New Agent as Agent for the Lenders, and the other Lenders parties thereto from time to time, and together with all general security agreements, trademark security agreements and patent security agreement entered into in connection therewith or in connection with prior versions thereof, the Lenders have severally agreed to make extensions of credit to the Borrower;

WHEREAS, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrower granted security interests in the certain intellectual property owned by Borrower, including those listed on Annex I attached hereto (the "**Intellectual Property Collateral**"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and each Agent hereby reassigns any and all such right, title and interest (if any) that such Agent may have in, to and under the Intellectual Property Collateral to Borrower.

Each Agent agrees, at Borrower's expense, to cooperate with Borrower and to provide Borrower with the information and additional authorization reasonably required or desirable to effect the release of such Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


