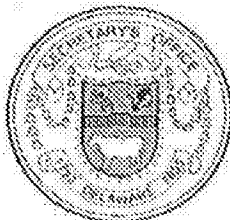

PLAN OF MERGER

Pursuant to the Utah Revised Limited Liability Company Act and the Delaware General Corporation Law, Newscycle Solutions Americas, LLC, a Utah limited liability company, hereby agrees to merge with and into Newscycle Solutions, Inc., a Delaware corporation, pursuant to the following terms:

1. The name of each entity that is a party to the merger is as follows:
 - a. Newscycle Solutions Americas, LLC, a Utah limited liability company (the "Merged Company").
 - b. Newscycle Solutions, Inc., a Delaware corporation (the "Surviving Corporation").
2. The name of the Surviving Corporation into which the Merged Company will merge is Newscycle Solutions, Inc., a Delaware corporation.
3. The merger shall become effective at 11:59 pm EST on December 31, 2015 (the "Effective Time"), at which time the Merged Company shall be merged with and into the Surviving Corporation, and the separate existence of the Merged Company shall thereupon cease.
4. The merger is intended to constitute a tax-free liquidation under Section 332 of the Internal Revenue Code of 1986, as amended.
5. Upon the Effective Time of the merger, all outstanding interests of the Merged Company shall be cancelled, and no interests of such company shall be issued in lieu thereof.
6. The Certificate of Incorporation and Bylaws of the Surviving Corporation shall not change as a result of the merger.
