TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination") is executed as of May 31, 2016, by Wells Fargo Bank, National Association ("Wells Fargo"), with reference to that certain Trademark Security Agreement, dated August 1, 2014, which was recorded with the United States Patent and Trademark Office on August 8, 2014, at reel and frame number 5340/0078, executed by The Sun Valley Group, Inc. ("Grantor"), and Wells Fargo (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Initially capitalized terms not defined in this Termination shall have the meanings set forth in the Security Agreement.

WHEREAS, the Grantor granted Wells Fargo, under the terms of the Security Agreement, a lien on and continuing security interest (the "Security Interest") in favor of Wells Fargo in and to all rights, title and interest in certain of Grantor's trademarks, including without limitation the trademarks listed on Schedule I attached hereto (collectively, the "Grantor Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by, the Grantor Trademarks.

WHEREAS, Wells Fargo has agreed to terminate and release its collateral pledge, grant, assignment, Security Interest, lien and all right, title and interest in all such Grantor Trademarks as herein provided.


For good and valuable consideration, receipt of which is hereby acknowledged, Wells Fargo hereby:

1. releases, cancels, terminates and discharges the Security Interest granted to Wells Fargo by Grantor with respect to all trademarks described in the Security Agreement, including, but not limited to, the Grantor Trademarks and all of the goodwill of the business connected with the use of, and symbolized by, the Grantor Trademarks; and
2. to the extent Wells Fargo shall be deemed to have any right, title or interest in the Grantor Trademarks, retransfers, reconveys and reassigns to Grantor all of the right, title and interest in such intellectual property, including the Security Interest and any other liens, without recourse and without representation or warranty of any kind whatsoever.

Wells Fargo hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other governmental official record this Termination. This Termination shall be governed by the laws of the State of California.
