

AAF-McQuay Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Company") does hereby certify:

**FIRST:** That the Board of Directors of said Company, by the unanimous written consent of its members, filed with the minutes of the Board, duly adopted a resolution proposing and declaring advisable the following amendment of the Certificate of Incorporation of said Company:

**RESOLVED**, that the Board of Directors hereby proposes and recommends, subject to approval by a favorable vote by a majority of the stockholders of the Company, that the name of the Company be changed to "Daikin Applied Americas Inc.", and that the appropriate officers of the Company file an amendment to the Certificate of Incorporation of the Company to effectuate such change.

**SECOND:** That in lieu of a meeting and vote of the stockholder, a Unanimous Written Consent of the Sole Stockholder in Lieu of Special Meeting of the stockholder of the Company was fully executed by the sole stockholder of the Company, giving unanimous written consent to the change in the name of the Company to Daikin Applied Americans Inc. and to the filing of all documents necessary or advisable to carry out such change, all in accordance with Section 228 of the General Corporation Law of the State of Delaware.

**THIRD:** That Article FIRST of the Certificate of Incorporation of AAF-McQuay Inc. is hereby deleted in its entirety and replaced in its entirety with the following:

**'FIRST: Corporate Name.** The name of the Corporation (which is hereinafter referred to as the "Corporation") is:


Daikin Applied Americas Inc."


**FIFTH:** This Certificate of Amendment shall be effective as of October 1, 2013.
