

(2) Cross Vetpharm Group Limited, a limited liability company incorporated under the laws of Ireland and having its registered office at First Floor, the Herbert Building, The Park, Carrickmines, Dublin 18, Ireland

(hereinafter referred to as the "Purchaser").

WHEREAS Assignor, Bayer HealthCare LLC (hereinafter referred to as "Seller") and Purchaser have entered into that certain Asset Sale And Purchase Agreement dated as of February 5, 2016 (the "Agreement") on the divestment of certain assets and liabilities relating to Seller's Products related Business in the U.S. as defined in the Agreement.

Section 1 Assignment

1.1 Assignor hereby assigns, transfers and sets over to Purchaser all rights, titles and interests in the Trademarks, together with (i) all privileges and advantages thereto including, without limitation, all associated goodwill, the right to take proceedings and recover damages and obtain all other remedies in respect of past infringements thereto, and (ii) all books, records and other documentation that are related to the Trademarks, to hold unto Purchaser absolutely and Purchaser herewith accepts the assignment of the Trademarks.

Section 2 Representations and Liability

2.1 Any representations, warranties or indemnifications with respect to the Trademarks, or any of the transactions described in the Agreement or in this TAA and any remedies of Purchaser are exclusively governed by the Agreement. Assignor makes no representations or warranties and offers no indemnifications beyond those contained in the Agreement

Section 3 Documentation and Costs

- 3.1 Purchaser shall be solely responsible for the preparation and recordation before the U.S. Patent and Trademark Office of all documents necessary to evidence Purchaser as new owner of the Trademarks. Assignor shall reasonably assist Purchaser in preparing and executing the documents necessary to record the assignment of the Trademarks in the name of Purchaser or any of its designated affiliates. Without limiting the generality of the foregoing, Assignor will use reasonable efforts to execute or cause to be executed all agreements and documents and to take or cause to be taken all other actions necessary under applicable laws and regulations to evidence the recording of Purchaser (or any of its designated affiliates) as the owner of the Trademarks.
- 3.2 All cost and expenses related to the preparation and recordation of all documents necessary to evidence Purchaser as new owner of the Trademarks shall be borne by Purchaser.
- 3.3 As of the Effective Date, the Assignee shall be solely responsible for maintaining and defending the Trademarks.
