Until such time as all of the assignments of Assignor’s intellectual property in all countries set forth in the annexed Schedule A are duly recorded with


the responsible government offices (the "Interim Period"), Assignor acknowledges and confirms that Assignee shall be deemed to be the owner of Assignor's trademarks identified on Schedule A.


