TRADEMARK ASSIGNMENT

WHEREAS, Assignee is desirous of acquiring all rights, title, and interest in and to the Trademark throughout the world; and

WHEREAS, Assignor is willing to assign to Assignee, free and clear, all goodwill, rights, title, and interest as Assignor may possess, in and to the Trademark worldwide.

NOW, THEREFORE, for the sum of ten dollars (\$10.00) and other good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged and intending to be legally bound hereby, Assignor hereby assigns, transfers, and conveys to Assignee, all rights, title, and interest as Assignor may possess in and to the Trademark worldwide, together with the goodwill symbolized by said Trademark.

This Assignment shall be binding upon and inure to the benefit of the Assignor and Assignee, and their respective principals, affiliates, subsidiaries, successors, and assigns.
