**RELEASE OF SECURITY INTEREST
INTELLECTUAL PROPERTY COLLATERAL ASSIGNMENT**

This RELEASE OF SECURITY INTEREST, dated June 8, 2016 (“Agreement”), is made and entered into among DEUTSCHE BANK AG CAYMAN ISLANDS BRANCH, as Administrative Agent for the Secured Parties (in such capacity, “Administrative Agent”), STATION CASINOS LLC, a Nevada limited liability company (the “Borrower”), NP OPCO LLC, a Nevada limited liability company (“Opc”), STATION GVR ACQUISITION, LLC, a Nevada limited liability company (“GVR”), NP IP HOLDINGS LLC, Nevada limited liability company (“IP Holdco”), FE LANDCO MANAGEMENT LLC, a Delaware limited liability company (“Landco”), and FERTITTA ENTERTAINMENT LLC, a Delaware limited liability company (“FE”, and together with Borrower, Opc, GVR, IP Holdco and Landco, each individually a “Grantor” and collectively the “Grantors”).

WHEREAS, the Borrower, the Lenders, certain other financial institutions and Administrative Agent entered into a Credit Agreement, dated as of March 1, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), and all capitalized terms not defined herein shall have the respective meaning given to them in the Credit Agreement;

WHEREAS, the Opc, GVR, IP Holdco, Landco, FE and certain other Subsidiaries of the Borrower guaranteed the repayment of the Obligations pursuant to a Guaranty Agreement, dated as of March 1, 2013 (as amended, restated, supplemented or otherwise modified from time to time);

WHEREAS, the Grantors, certain Subsidiaries of the Borrower and the Administrative Agent have entered into a Security Agreement dated as of March 1, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, to secure its obligations under the Credit Agreement and the Security Agreement, the Grantors entered into that certain (i) Confirmatory Grant of Security Interest in United States Intellectual Property, dated March 1, 2013 and recorded with the U.S. Patent and Trademark Office (“USPTO”) on May 29, 2013 at Reel/Frame Nos. 5036/0338, 5037/0141, 5037/0201, 5037/0223, 30508/0727 and with the U.S. Copyright Office (“USCO”) on June 3, 2013 at V3629 D232 (collectively, the “May 2013 Collateral Assignment”), (ii) Confirmatory Grant of Security Interest in United States Intellectual Property, dated June 18, 2013 and recorded with the USPTO on June 20, 2013 at Reel/Frame No. 30666/0116 (the “June 2013 Collateral Assignment”), (iii) Confirmatory Grant of Security Interest in United States Intellectual Property, dated November 13, 2013 and recorded with the USPTO on November 21, 2013 at Reel/Frame No. 5159/0092 (the “November 2013 Collateral Assignment”), (iv) Confirmatory Grant of Security Interest in United States Intellectual Property, dated August 13, 2014 and recorded with the USPTO on September 26, 2014 at Reel/Frame No. 5369/0509 (the “August 2014 Collateral Assignment”), (v) Confirmatory Grant of Security Interest in United States Intellectual Property, dated January 9, 2015 and recorded with the USPTO on February 3, 2015 at Reel/Frame No. 5451/0979 (the “January 2015 Collateral Assignment”), (vi) Confirmatory Grant of Security Interest in United States Intellectual Property, dated November 6, 2015 and recorded with the USPTO on December 22, 2015 at Reel/Frame No. 5696/0149 (the “November 2015 Collateral Assignment”), (vii) Confirmatory Grant of Security Interest in United States Intellectual Property, dated May 2, 2016 and recorded with the USPTO on May 3, 2016 at Reel/Frame No. 5784/0207 (the “May 2016 Collateral Assignment”, and together with the May 2013 Collateral Assignment, the June 2013 Collateral Assignment, the November 2013 Collateral Assignment, the August

2014 Collateral Assignment, the January 2015 Collateral Assignment and the November 2015 Collateral Assignment, each individually a “Collateral Assignment” and collectively the “Collateral Assignments”), wherein the Grantors assigned certain collateral to the Administrative Agent, including the Copyrights, Trademarks, Patents, and Licensed Trademarks (each as defined in the Collateral Assignments) listed in **Schedule A** attached hereto (collectively, the “Assigned Intellectual Property”); and

WHEREAS, all obligations under the Credit Agreement have been satisfied and all liens under the Security Agreement and the Collateral Assignments have been terminated, and Administrative Agent wishes to terminate and release all security interests, pledges, assignments, mortgages and liens of record granted to it in the Assigned Intellectual Property under the Security Agreement and the Collateral Assignments.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent and the Grantors agree as follows:

1. Release. Administrative Agent hereby discharges, terminates and releases all security interests, pledges, assignments, mortgages and liens granted to it (collectively, “Security Interests”) in the Assigned Intellectual Property under the Collateral Assignments, and agrees that all of the Security Interests in the Assigned Intellectual Property are hereby discharged, terminated and released and hereby transfers and assigns to the Grantors any and all right, title and interest that Administrative Agent may have obtained in, to and under the Assigned Intellectual Property under the Security Agreement and the Collateral Assignments.

2. Perfection. Each of the Grantors and Administrative Agent hereby authorizes the Director of the USCO and the USPTO to record this Agreement to reflect the release of Security Interests and reassignment of any interests with respect to the Assigned Intellectual Property.




