ASSIGNMENT OF U.S. TRADEMARKS

WHEREAS, Akzo Nobel Pulp and Performance Chemicals A.B., a corporation organized under the laws of Sweden, ("ANPP") and Ecolab Inc., a corporation organized under the laws of Delaware and having a place of business at 655 Lone Oak Drive, Eagan, MN 55121, ("Assignee") entered into that certain Asset Purchase Agreement dated April 21, 2013 ("APA"), wherein ANPP and certain of its affiliates agreed to sell certain assets to Assignee;

NOW, THEREFORE, effective as of April 21, 2013, for and in consideration of the sum of One Dollar (\$1.00), to it in hand paid by said Assignee, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said Assignor does hereby sell, assign, transfer and set over to said Assignee all its right, title and interest in, to and under said Marks and registrations, together with the goodwill of the business symbolized by the Marks, together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement, said rights to be held and enjoyed by said Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by said Assignor if this Assignment and sale had not been made.

AND, said Assignor hereby covenants that it has full right to convey the entire interest herein assigned.
