

ARTICLES OF AMENDMENT

Northwest Savings Bank

Warren, Warren County, Pennsylvania

TO THE COMMONWEALTH OF PENNSYLVANIA
DEPARTMENT OF BANKING AND SECURITIES:

Pursuant to the provisions of Chapter 15 of the Pennsylvania Banking Code of 1965 (P.L. 847, No. 356), as amended, the undersigned institution hereby submits these Articles of Amendment:

ARTICLE I. The name of the institution is Northwest Savings Bank.

ARTICLE II. The location and post office address of its principal place of business are 301 2nd Avenue, Warren, Pennsylvania 16365.

ARTICLE III. The institution was incorporated on August 20, 1896, under the provisions of the then applicable Pennsylvania banking law under which the institution was incorporated.

ARTICLE IV. The amendment hereinafter set forth was authorized by the Board of Directors of the institution at a regular meeting held on October 14, 2014 and adopted at a regular meeting of the Sole Shareholder of the institution, Northwest Bancorp, held at 301 2nd Avenue, Warren, PA 16365 on October 14, 2014. No special notice was required for the regular meeting or Sole Shareholder action.

ARTICLE V. At the time of this meeting of the Sole Shareholder of the institution, there were 100 shares of common stock of the institution entitled to vote on the amendment.

ARTICLE VI. At the time of this meeting of the Sole Shareholder of the institution, 100 shares of common stock of the institution were voted for the proposed amendment and zero (0) shares of common stock of the institution were voted against the proposed amendment.

ARTICLE VII. The resolution approved by the Board of Directors of the institution and adopted by the Sole Shareholder of the institution, providing for the amendment, in order to correct the filing of November 12, 2014 to change the name of the bank and to conform to the requirements of the Banking Code of 1965 was as follows:

RESOLVED:

Article I of the Articles of Incorporation be amended and restated to read as follows:

Article I: The name of the institution is Northwest Bank.

IN TESTIMONY WHEREOF, the undersigned has caused these Amended Articles of Amendment to be signed by its Executive Vice President and its corporate seal, duly attested by its Assistant Corporate Secretary to be hereunto affixed this 14th day of September, 2015 in order to amend the Articles of Amendment filed with the Pennsylvania Department of State Bureau of Corporations and Charitable Organizations filed on November 12, 2014.


