TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 3, 2016, by PNC Bank, National Association, as agent ("Grantee").

WITNESSETH:

WHEREAS, Grantee and Access Point, Inc., a North Carolina corporation ("Grantor"), entered into that certain Grant of Security Interest in United States Trademark dated as of June 17, 2013 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Grantor granted a security interest to Grantee in, among other things, all of Grantor's right, title and interest in and to the United States trademark number 2965180 registered on July 5, 2005 (the "Mark"); and
