**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of May 9, 2016 ("Release"), is made by Wok Member LLC, as lender (the "Secured Party") in favor of FRC Balance, LLC, (individually, the "Grantor").

**WHEREAS**, pursuant to that certain Intellectual Property Security Agreement dated as of December 7, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantor and the Secured Party, the Grantor granted to the Secured Party, for its benefit, a continuing security interest in any and all right, title and interest in, to, and under all the Collateral, including all Patents, Patent Licenses, and all Accessions and Proceeds of the foregoing;

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Secured Party, agrees as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates the Security Agreement and terminates, cancels, discharges, and releases all mortgages, pledges, and hypothecations and liens on and security interests in and to, and rights of set off against, the Grantor's right, title, and interest in, to, and under all Patents, all Patent Licenses, and all Accessions and all Proceeds of the foregoing, including, but not limited to, the Grantor's patents and patent applications listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Secured Party, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.
