ASSIGNMENT OF INTEREST IN TRADEMARKS


WHEREAS, the Assignee wishes to acquire the Assignor's rights in the Trademark.

3. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the assignment hereby given.
