**IP SECURITY AGREEMENT SUPPLEMENT**

This IP SECURITY AGREEMENT SUPPLEMENT dated June 10, 2016 (this "Supplement"), is delivered pursuant to the Intellectual Property Security Agreement dated as of April 16, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), among Cenveo, Inc., a Colorado corporation ("Holdings"), Cenveo Corporation, a Delaware corporation (the "Borrower"), each other Domestic Subsidiary (such term and the other capitalized terms used and not defined in this Supplement have the meanings assigned thereto in the IP Security Agreement) of Holdings from time to time party thereto (Holdings, the Borrower and such Domestic Subsidiaries, each a "Grantor" and, collectively, the "Grantors") and Bank of America, N.A., as administrative agent and collateral agent (in such capacity, the "Administrative Agent") for the Secured Parties.

WHEREAS, each Grantor and the Administrative Agent have authorized Holdings to supplement the scheduled information with respect to such Grantor set forth in the IP Security Agreement from time to time as required by the Pledge and Security Agreement.

Holdings, on its own behalf and on behalf of each other Grantor, hereby certifies to the Administrative Agent and each other Secured Party that, as of the date hereof, each of the Schedules to the IP Security Agreement are hereby supplemented and amended by the additions set forth on the schedules hereto; provided, that no such supplement or amendment shall release or be deemed to release any security interest in any Collateral granted to the Administrative Agent and the Secured Parties pursuant to the IP Security Agreement.

Holdings, on its own behalf and on behalf of each other Grantor, hereby covenants and agrees to enter into each other instrument as the Administrative Agent deems necessary and proper to perfect its security interest in the Intellectual Property described herein.
