TERMINATION OF NOTICE OF SECURITY INTEREST IN U.S. TRADEMARKS

June 10, 2016

WHEREAS, DIANNE'S FINE DESSERTS, INC., a Delaware corporation (the "Grantor"), had mortgaged, pledged, granted and conveyed to THE HUNTINGTON NATIONAL BANK (the "Lender"), a first-priority security interest (the "Security Interest") in and to all of the Grantor's right, title and interest in and to the United States trademarks listed on the annexed Schedule A, which trademarks are registered in or subject to trademark applications filed in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill associated therewith, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the "Trademark Collateral"), pursuant to, among other things, a certain Notice of Security Interest in U.S. Trademarks dated as of May 11, 2012 (the "Agreement"; capitalized terms used herein but not otherwise defined herein shall have the meanings assigned to such terms in the Agreement), which was filed at the United States Patent and Trademark Office on May 25, 2012 and recorded on Reel 4788, Frame 0524; and

WHEREAS, the Grantor has made payment in full of the indebtedness secured by the Security Interest in exchange for the termination of the Security Interest.


