**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
VACO, LLC**

Pursuant to Section 48-209-104 of the Tennessee Limited Liability Company Act, the undersigned limited liability company (the "Company") adopts the following amendments to its Articles of Organization (the "Articles of Organization"):

- 1. The name of the limited liability company is VACO, LLC.
- 2. The Tennessee Secretary of State Control Number of said limited liability company is 000432576.
- 3. The text of each amendment adopted is:
 - 1. The name of the limited liability company is VACO Nashville, LLC.
 - 4. The LLC will be director managed.
 - 11A. The LLC elects to be governed by the Tennessee Revised Limited Liability Company Act.
 - 11B. The LLC shall not be a family LLC as such term is defined in the Tennessee Revised Limited Liability Company Act.
- 4. The amendments were duly adopted on August 24, 2012 by the members.
