## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of June 9, 2016 by CITIZENS BUSINESS CAPITAL, a division of Citizens Asset Finance, Inc., as Administrative Agent (the "*Grantee*") in favor of GREGG PROTECTION SERVICES, INC., a Pennsylvania corporation (the "*Grantor*").

**WHEREAS**, the Grantor executed and delivered a Grant of Security Interest in Trademarks, dated as of March 30, 2015 (as amended, modified or supplemented prior to the date hereof, the "*Grant*"; capitalized terms used but not defined herein shall have the meaning ascribed to them in the Grant), granting the Grantee a continuing security interest in the following: (i) all of the Grantor's right, title and interest in, to and under the trademarks, service marks, trademark registrations, and service mark registrations set forth on Schedule A attached hereto and any reissues, renewals, continuations and extensions thereof (collectively, the "*Trademarks*"), (ii) all Proceeds and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same;

**WHEREAS**, the Grant was recorded in the Assignment Division of the United States Patent and Trademark Office ("*USPTO*") on April 1, 2015, at Reel 5489, Frame 0272;

**WHEREAS**, the Grantor has requested that the Grantee hereby terminate, release and discharge fully its continuing security interest described in the Grant as herein provided; and

**WHEREAS**, the Grantor has requested that the Grantee provide a document suitable for recording in the USPTO to evidence the release of its continuing security interest as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the Grant and releases, terminates and discharges its continuing security interest with respect to Grantor and its successors and assigns as described in the Grant, including as applicable to those Trademarks identified in Schedule A attached hereto and all goodwill associated therewith; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO by Grantor.

THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK WITHOUT GIVING EFFECT TO ANY APPLICABLE LAW THAT WOULD CAUSE THE APPLICATION OF THE LAW OF ANY OTHER JURISDICTION.
