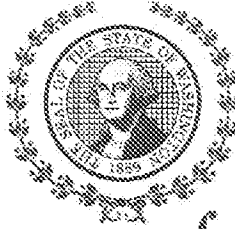

Pursuant to Chapter 23B.09.040 of the Revised Code of Washington ("*RCW*") and Section 18-214 of the Limited Liability Company Act of the State of Delaware (the "*Act*"), the following Articles of Conversion are herewith submitted for filing.

1. Classic Accessories, Inc., a Washington corporation (the "*Converting Entity*") has been converted into Classic Accessories, LLC, a Delaware limited liability company (the "*Surviving Entity*").
2. Prior to the conversion, the name and form of the Converting Entity was Classic Accessories, Inc., a Washington corporation incorporated on January 3, 1984.
3. At the effective time of the conversion, the name and form of the Surviving Entity shall be Classic Accessories, LLC, a Delaware limited liability company.



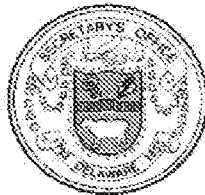


