**ASSIGNMENT OF TRADEMARK**

WHEREAS, Texas Industries, Inc. (hereinafter referred to as ASSIGNOR), a corporation organized under the laws of the state of Delaware, is the owner of record of the trademark THE FASTER PLASTER, which is registered in the United States Patent and Trademark Office under Registration No. 4,162,600 and which issued June 19, 2012 (the mark and registration hereinafter referred to collectively as The Faster Plaster Mark); and

WHEREAS, CalPortland Company (hereinafter referred to as ASSIGNEE), a corporation organized under the laws of the state of California, having a mailing address of 2025 E. Financial Way, Glendora, California 91741, is desirous of acquiring the entire right, title, and interest of ASSIGNOR in to and under The Faster Plaster Mark, together with the goodwill of the business associated with The Faster Plaster Mark; and

WHEREAS, by Asset Purchase Agreement dated June 30, 2015 which transaction closed on October 1, 2015, ASSIGNOR sold all of its right, title and interest in and to The Faster Plaster Mark to ASSIGNEE and, pursuant to the Asset Purchase Agreement, agreed to formally assign all of its right, title and interest in The Faster Plaster Mark to ASSIGNEE, on the conditions, representations and warranties contained in the aforesaid Asset Purchase Agreement;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said ASSIGNOR, by these presents, does sell, assign and transfer unto ASSIGNEE the entire right, title and interest in and to said The Faster Plaster Mark and the goodwill of the business in connection with which said The Faster Plaster Mark is used and all claims for damages by reason of past and present infringement of The Faster Plaster Mark, and the right to sue for and collect such damages.

This assignment is made effective as of October 1, 2015.
