OF CERTIFICATE OF INCORPORATION

The corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

FIRST: That by unanimous written consent in lieu of a meeting pursuant to the By-laws and the General Corporation Law of the State of Delaware, the Board of Directors of Ocata Therapeutics, Inc.
