## INTELLECTUAL PROPERTY ASSIGNMENT

### WITNESSETH:

WHEREAS, Assignor is the owner of the domain name registrations attached hereto as Exhibit B (collectively, the "Domains" and together with the Trademarks the "Intellectual Property");

WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title and interest in and to the Intellectual Property, together with all goodwill associated with the Intellectual Property s; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Intellectual Property, together with all goodwill associated with the Intellectual Property;

NOW, THEREFORE, in consideration of the payment of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby grants, sells, assigns, transfers, and conveys to Assignee all of its right, title and interest in and to the Intellectual Property , together with all goodwill associated with the Intellectual Property , and the right to sue and recover any damages and profits and all other remedies for past, present and future infringements or violations thereof, if there may be any, the same to be held and enjoyed by the Assignee as it would have been held and enjoyed by the Assignor had the grant, sale, assignment, transfer and conveyance not been made.

2. Title. Assignor hereby represents and warrants that it has the full right to convey, free of licenses and encumbrances, all right, title and interest in and to the Intellectual Property.

3. Cooperation. Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this Assignment. Assignor consents and authorizes Assignee or Assignee's designee to file and record this Assignment as necessary to perfect title in Assignee.

4. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.

5. Entire Agreement. This Assignment contains the entire agreement and understanding of the parties hereto relating to the subject matter hereof, and merges and supersedes all prior and contemporaneous discussions, agreements and undertakings of every nature between the parties hereto relating to the subject matter hereof. This Assignment may not be changed or modified, except by an agreement in writing signed by each of the parties hereto.




