**Trade Mark Assignment Agreement**

THIS AGREEMENT is dated 11 December 2014, and effective on 31 December 2014

#### **PARTIES**

- (1) **Zenbury International Limited** (formerly known as Kerry Group Services International Limited), a Luxembourg private limited liability company, incorporated and governed by the laws of the Grand-Duchy of Luxembourg, with its principal office at 17, rue Antoine Jans, L-1820 Luxembourg and its registered office for Irish corporate law purposes at Prince's Street, Tralee, Co Kerry, registered with the Luxembourg Register of Companies and Commerce under number B 166.658 and having a share capital of EUR 12,500.- (**the Assignor**); and
- (2) **Kerry Luxembourg S.à r.l.**, a Luxembourg private limited liability company, incorporated and governed by the laws of the Grand-Duchy of Luxembourg, with registered office at 17, rue Antoine Jans, L-1820 Luxembourg, registered with the Luxembourg Register of Companies and Commerce under number B 162.299 and having a share capital of EUR 125,000.- (**the Assignee**)

#### **BACKGROUND**

- (A) The Assignor is the proprietor of or applicant for the Trade Marks (as defined below).
- (B) By the Main Agreement (as defined below) the Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out in this agreement.

#### **AGREED TERMS**

##### **1. INTERPRETATION**

The following definitions and rules of interpretation apply in this agreement.

##### **1.1 Definitions:**

**Business Day:** a day (other than a Saturday or Sunday) on which clearing banks are generally opened for business in Luxembourg and Ireland.

**Main Agreement:** an agreement for the transfer of a going concern dated the 11<sup>th</sup> of December, 2014 between the Assignor and the Assignee.

**Trade Marks:** the trade marks listed in Schedule 1.

##### **1.2** Clause, Schedule and paragraph headings shall not affect the interpretation of this agreement.

##### **1.3** The Schedules form part of this agreement and shall have effect as if set out in full in the body of this agreement. Any reference to this agreement includes the Schedules.

- 1.4 References to clauses and Schedules are to the clauses and Schedules of this agreement.
- 1.5 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.6 This agreement shall be binding on, and ensure to the benefit of, the parties to this agreement and their respective personal representatives, successors and permitted assigns, and references to any party shall include that party's personal representatives, successors and permitted assigns.
- 1.7 A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time.
- 1.8 A reference to a statute or statutory provision shall include any subordinate legislation made from time to time under that statute or statutory provision.
- 1.9 A reference to **writing** or **written** includes faxes but not email.
- 1.10 Any words following the terms **including**, **include**, **in particular**, **for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.

## 2. **ASSIGNMENT**

- 2.1 Pursuant to and for the consideration set out in the Main Agreement, the Assignor hereby assigns to the Assignee absolutely with full title guarantee all its right, title and interest in and to the Trade Marks, including:
- (a) the absolute entitlement to any registered trade marks granted pursuant to any of the applications comprised in the Trade Marks; and
  - (b) all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods or services in respect of which the Trade Marks are registered or used; and
  - (c) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of any of the Trade Marks whether occurring before, on or after the date of this agreement.

**3. FURTHER ASSURANCE**

- 3.1 At its own expense the Assignor shall, and shall use all reasonable endeavours to procure that any necessary third party shall, promptly execute such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this agreement, including registration of the Assignee as applicant or registered proprietor of the Trade Marks.
- 3.2 The Assignee grants to the Assignor on the 31 December, 2014 the right and power of attorney to in its name and on its behalf perform all necessary actions, and sign all the necessary documents, to record the transfer of the Trade Marks to the Assignee and perform any necessary registration of such transfer in all applicable jurisdictions.
- 3.3 The Assignor acknowledges the authority granted to it in clause 3.2 and undertakes to do everything that is necessary in order to register the registered Trade Marks in the Assignee's name on the 31 December, 2014, including but not limited to the signing of any further documents.

**4. WAIVER**

No failure or delay by a party to exercise any right or remedy provided under this agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

**5. VARIATION**

No variation of this agreement shall be effective unless it is in writing and signed by the parties (or their authorised representatives).

**6. SEVERANCE**

- 6.1 If clause of this agreement is or becomes void, unenforceable or prohibited in any jurisdiction, this shall not affect the validity and enforceability of the other terms of this agreement or the validity and enforceability of such clause in any other jurisdiction. In any such event, the parties to this agreement will substitute a valid and enforceable clause in the place of the invalid, unenforceable or prohibited clause in the spirit and to the effect of the latter.

**7. COUNTERPARTS**

- 7.1 This agreement may be authenticated in any number of counterparts, all of which taken together shall constitute one and the same instrument. Any of the parties

hereto may authenticate this agreement by signing any such counterpart. This agreement may be authenticated by manual signature, facsimile or electronic means, all of which shall be equally valid.

**8. NOTICES**

- 9.1 Any notice or other communication required or permitted to be given hereunder shall be in writing and shall be delivered in person, transmitted by facsimile or similar means of recorded electronic communication or sent by registered mail, charges prepaid.
- 9.2 Any such notice or other communication shall be deemed to have been given and received on the day on which it was delivered or transmitted if so delivered or transmitted prior to 6:00 p.m. local time at the place of the receipt, or, if mailed, on the fifth day following the date of mailing.
- 9.3 Any party may at any time change its address for service from time to time by giving notice to the other parties in accordance with this clause.

**9. GOVERNING LAW AND JURISDICTION**


- 10.1 This Agreement is governed by, and shall be construed in accordance with, the laws of the Grand Duchy of Luxembourg.


