RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated June 15, 2016 by LLOYDS BANK PLC ("*Security Agent*"), with its mailing address at 25 Gresham Street, London, United Kingdom EC2V 7HN;

WITNESSETH:

WHEREAS, STEELITE INTERNATIONAL U.S.A. WHEREAS, Grantor has requested that Security Agent release its security interests in the Trademark Collateral and reassign the same to Grantor;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Security Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Security Agent, all of its right, title and interest, if any, in and to each trademark registration, and trademark application listed on Schedule I hereto, including:

- (i) all of its Trademarks and all Trademark Licenses providing for the grant by or to such Grantor of any right under any Trademark, including without limitation, those referred to on Schedule I;
- (ii) all renewals and extensions of the foregoing;
- (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (iv) all income, royalties, payment and proceeds at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.
