TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT entered into as of June 17, 2016 (as it may be amended, restated, supplemented or otherwise modified from time to time, this "Agreement"), by and between Gold's Gym Licensing LLC a limited liability company (the "Grantor"), and JPMorgan Chase, Bank, N.A., in its capacity as administrative agent (the "Administrative Agent"), for the benefit of the Administrative Agent and the other Secured Lenders.

PRELIMINARY STATEMENT

JPMorgan Chase Bank, N.A., as the Administrative Agent, Swingline Lender and Issuing Bank, the Lenders party thereto, and GGI Holdings, LLC, a Delaware limited liability company (the "Borrower"), are entering into that certain First Amended and Restated Credit Agreement dated as of June 17, 2016 (as it may be amended, restated, modified and supplemented from time to time, the "Credit Agreement"). In connection with the Credit Agreement, Grantor executed and delivered the Amended and Restated Pledge and Security Agreement dated as of June 17, 2016 (such agreement, together with all amendments and restatements thereto, the "Security Agreement"), in order to induce the Lenders to enter into and extend credit to the Borrower under the Credit Agreement, the Secured Lenders to provide Banking Services to the Grantor and the Secured Lenders to enter into Swap Agreements with Grantor, and to secure the Obligations.

As a condition precedent to the making of the Loans and other Transactions contemplated under the Credit Agreement, Grantor is required to execute and deliver this Agreement and to grant to Administrative Agent a continuing security interest, for its benefit and the ratable benefit of the Secured Lenders, in all of the Trademark Collateral (as defined below) to secure all Obligations;

ACCORDINGLY, the Grantor and the Administrative Agent, on behalf of the Secured Lenders hereby agree as follows:

AGREEMENT.

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided (or incorporated by reference) in the Security Agreement.

"Trademark License" means all right, title, and interest of the Grantor (in each case whether now or hereafter existing, owned, arising, or acquired) in and to any written agreement, now or hereafter in effect, granting to any third party any right to use any Trademark now or hereafter owned by the Grantor or which the Grantor otherwise has the right to license, or granting to such Grantor any right to use any Trademark now or hereafter owned by any third party, and all rights of the Grantor under any such agreement.

"Trademarks" means all right, title, and interest of the Grantor (in each case whether now or hereafter existing, owned, arising, or acquired) in and to (a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, all registrations and recordings thereof, and all registration and recording applications filed with any Governmental Authority in connection therewith, and all extensions or renewals thereof, (b) all goodwill associated therewith or symbolized thereby, (c) all other assets, rights and interests that uniquely reflect or embody

such goodwill, (d) all rights to use and/or sell any of the foregoing, and (e) the portion of the business to which each trademark pertains.

2. Grant of Security Interest. Grantor hereby pledges, assigns and grants to the Administrative Agent, on behalf of and for the benefit of the Secured Lenders, a security interest in all of the following property (the "Trademark Collateral"), whether now owned or hereafter acquired by it:

(a) all Trademarks, including all Trademarks referred to in Item A of Schedule 1 attached hereto;

(b) all applications for Trademarks, including each Trademark application referred to in Item B of Schedule 1 attached hereto; and

(c) all Trademark Licenses, including all Trademark Licenses referred to in Item A of Schedule 1 attached hereto; and

(d) all proceeds and products of the foregoing, including, without limitation, insurance payable by reason of loss or damage to the foregoing.

3. Security Agreement. This Agreement has been executed and delivered by Grantor for the purpose of recording the security interest of the Administrative Agent, on behalf of and for the benefit of the Secured Lenders, in the Trademark Collateral in the United States Patent and Trademark Office and corresponding offices in the United States and any state thereof. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to the Administrative Agent, on behalf of and for the benefit of the Secured Lenders, under the Security Agreement. The Security Agreement (and all rights and remedies of the Administrative Agent, on behalf of and for the benefit of the Secured Lenders thereunder) shall remain in full force and effect in accordance with its terms.

4. Acknowledgment. Grantor does hereby further acknowledge and affirm that the rights and remedies of the Administrative Agent, on behalf of and for the benefit of the Secured Lenders, with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

5. Loan Document, etc. This Agreement is a Loan Document executed pursuant to the Credit Agreement and shall (unless otherwise expressly indicated herein) be construed, administered and applied in accordance with the terms and provisions of the Credit Agreement.

6. Counterparts. This Agreement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be duly executed and delivered by their respective officers thereunto duly authorized as of the day and year first above written.
