**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of June 16, 2016, by JEFFERIES FINANCE LLC, a Delaware limited liability company, as Collateral Agent (as such term is used in the Trademark Security Agreement described below) (the “Grantee”), in favor of ICONTACT LLC, a Delaware limited liability company with principal offices at 12051 Indian Creek Court, Beltsville, Maryland 20705 (the “Grantor”).

W I T N E S S E T H:

WHEREAS Grantor entered into a certain first lien trademark security agreement dated May 30, 2014 (the “Trademark Security Agreement”) with the Grantee, notice of which was recorded on May 30, 2014 at the United States Patent and Trademark Office at Reel 5292, Frame 0725.

WHEREAS, Grantor granted the Grantee, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Grantee, in and to certain of Grantor’s intellectual property, including without limitation the trademarks listed in **Schedule A** (collectively, the “Trademarks”) and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement.

WHEREAS, the Grantee has agreed to terminate and release its security interest in all such Trademarks as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Grantee, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Grantor, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens.
