TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, The Mitchell Gold Co., a North Carolina corporation having an address of 135 One Comfortable Place, Taylorsville, North Carolina 28681 (the “Grantor”), granted a security interest to SALUS CAPITAL PARTNERS, LLC, a Delaware limited liability company with a principal place of business at 197 First Avenue, Suite 250, Needham, Massachusetts 02494 (the “Secured Party”), in Grantor’s trademarks pursuant to and as reflected in that certain Grant of Security Interest in United States Trademarks dated as of December 10, 2012, which was filed at the United States Patent and Trademark Office on May 9, 2013 and recorded on Reel 5026, Frame 0167 (the “Grant”); and

WHEREAS, the security interests granted by the Grantor to Secured Party under the Grant have been terminated.


NOW, THEREFORE, to the full extent of the Grant, Secured Party releases its security interest in (i) all of Grantor’s right, title and interest in, to and under any United States trademarks, trademark registrations, and trademark applications, including, without limitation, the United States trademarks, trademark registrations, and trademark applications set forth on Exhibit A attached hereto (all of the foregoing, collectively, the “Marks”), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after December 10, 2012 for infringement of any of the Marks or unfair competition regarding the same.

Secured Party agrees that, upon the request of the Grantor or any successor in interest or assignee thereof, and at the expense of the Grantor, Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantor, or any successor in interest or assignee thereof, to effectuate the release of interests contemplated herein.
