**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of June 21, 2016 (this "Release"), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as collateral agent (in such capacity, the "Collateral Agent"), in favor of AVANTOR PERFORMANCE MATERIALS, INC., a New Jersey corporation (the "Grantor"), as follows:

WITNESSETH

WHEREAS, pursuant to the (a) Trademark Security Agreement, dated as of October 8, 2010 (the "2010 Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on October 8, 2010 at Reel/Frame 4293/0283; (b) Trademark Security Agreement, dated as of June 24, 2011 (the "2011 Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on June 24, 2011 at Reel/Frame 4569/0045; and (c) Trademark Security Agreement, dated as of October 1, 2014 (the "2014 Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on October 2, 2014 at Reel/Frame 5373/0524, as security for the payment or performance, as the case may be, in full of the Obligations, the Grantor pledged to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, and granted to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by the Grantor or in which the Grantor then had or at any time in the future may acquire any right, title or interest (collectively, the "Released Trademark Collateral"):

- (a) trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, and designs, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and pending applications filed in connection therewith, including registrations and pending applications in the United States Patent and Trademark Office (or any successor office) or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule I thereto;
- (b) all goodwill associated therewith or symbolized thereby;
- (c) all other assets, rights, and interests that uniquely reflect or embody such goodwill, but excluding in all cases any intent-to-use United States trademark application for which an amendment to allege use or statement of use has not been filed under 15 U.S.C. § 1051(c) or 15 U.S.C. §1501(d), respectively, or, if filed, has not been deemed in conformance with 15 U.S.C. §1051(a) or examined and accepted, respectively, by the United States Patent and Trademark Office; and

(d) all Proceeds and products of any and all of the foregoing, all Supporting Obligations and all collateral security and guarantees given by any Person with respect to any of the foregoing; and

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in all of the Grantor's right, title or interest in or to the Released Trademark Collateral.

NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty of any kind or nature, and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its security interest in all of the Grantor's right, title and interest in or to the Released Trademark Collateral, including the trademarks listed on Schedules A, B and C hereto, and any and all right, title and interest of the Collateral Agent in the Released Trademark Collateral shall hereby terminate, cease and become void.


The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
