## ASSIGNMENT OF MARKS

WHEREAS, ORIGIN BANK F/K/A COMMUNITY TRUST BANK, a Louisiana banking corporation having a place of business at 1511 North Trenton Street, Ruston, Louisiana 71270, adopted and used in commerce the marks shown in Exhibit 1 ("the Marks") attached hereto;

WHEREAS, ORIGIN BANK F/K/A COMMUNITY TRUST BANK became a subsidiary of ORIGIN BANCORP, Inc F/K/A COMMUNITY TRUST FINANCIAL CORPORATION, a Louisiana corporation and holding company, in 1991;

WHEREAS, ORIGIN BANK F/K/A COMMUNITY TRUST BANK and ORIGIN BANCORP, INC. F/K/A COMMUNITY TRUST FINANCIAL CORPORATION have used the word marks COMMUNITY TRUST and COMMUNITY TRUST BANK of the Marks in association with banking and related services since 1987;

WHEREAS, ORIGIN BANK F/K/A COMMUNITY TRUST BANK and ORIGIN BANCORP, INC. F/K/A COMMUNITY TRUST FINANCIAL CORPORATION have used the COMMUNITY TRUST BANK & Design mark (U.S. Reg. No. 3,743,528) of the Marks in association with banking and related services since at least as early as January 5, 2003, and registered the mark in the U.S. Patent and Trademark Office as U.S. Reg. No. 3,743,528, such registration now abandoned;

WHEREAS, ORIGIN BANK F/K/A COMMUNITY TRUST BANK and ORIGIN BANCORP, INC F/K/A COMMUNITY TRUST FINANCIAL CORPORATION have used the COMMUNITY TRUST BANK & Design mark (U.S. Reg. App. Ser. No. 76/685,026) of the Marks in association with banking and related services since at least as early as October 26, 2007, and sought registration of the mark in the U.S. Patent and Trademark Office, such application now abandoned;

WHEREAS, COMMUNITY TRUST BANCORP, INC., a Kentucky corporation, and its predecessors, adopted the COMMUNITY TRUST word mark in 1995 and has continuously used the mark in association with banking and related services; and

WHEREAS, a conflict arose between COMMUNITY TRUST BANCORP, INC., and ORIGIN BANK F/K/A COMMUNITY TRUST BANK and ORIGIN BANCORP, INC. F/K/A COMMUNITY TRUST FINANCIAL CORPORATION, which conflict settled in accordance with a Settlement Agreement entered into by the parties on April 10, 2014.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ORIGIN BANK F/K/A COMMUNITY TRUST BANK and ORIGIN
