**Termination of Trademark Security Agreement**

This Termination of Trademark Security Agreement (this "Trademark Termination") is executed on the date set forth below by ALOSTAR BANK OF COMMERCE, a state banking institution incorporated or otherwise organized under the laws of the State of Alabama ("Alostar"), with respect to the following facts:

A. Alostar previously recorded with the U.S. Patent and Trademark Office ("USPTO") one or more copies of a Trademark Security Agreement, dated as of March 18, 2014, by and between Patriot Environmental Services, Inc. a California corporation ("Debtor") and Alostar (the "Security Agreement"), pursuant to which Debtor granted Alostar a security interest in the Trademark Collateral, including, without limitation, the Trademark described in Exhibit A hereto (the "Trademark"). Capitalized terms used herein but not otherwise defined shall have the meanings ascribed to them in the Security Agreement.

B. Alostar, Debtor and each of the parties thereto, entered into that certain Request for Payoff of Loan and Security Agreement, dated as of June 15, 2016, pursuant to which the security interest granted by Debtor to Alostar as reflected by the Security Agreement was terminated, released and discharged, and is of no further force or effect and AloStar hereby assigns, transfers and conveys to Debtor all of AloStar's right, title and interest in and to the Trademark Collateral, including, without limitation, the Trademark.


