

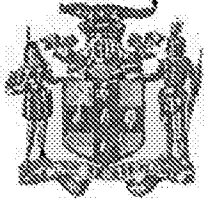

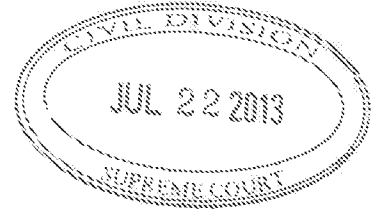

UPON THE WITHOUT NOTICE OF APPLICATION FOR COURT ORDERS TO SANCTION SCHEME OF ARRANGEMENT FILED ON JULY 18, 2013 ON BEHALF OF Lascelles, deMercado & Co. Limited (“LdM”), Wray & Nephew Group Limited (“W&N Group”), J. Wray & Nephew Limited (“JW&N”), Daniel Finzi & Company (Successors) Limited (“Daniel Finzi”), Edwin Charley Limited (“Edwin Charley”), Sugar Mills Limited (“Sugar Mills”), Rum Company (Jamaica) Limited (“Rum Company”), Appleton Estate Limited (“Appleton Estate”),

Grange Hill Products Limited (“GH Products”), Estate Industries Limited (“Estate Industries”), T.T.L. Rum Bottlers Limited (“TTL”), Newton Cane Farms Limited (“Newton”), New Yarmouth Holdings Limited (“NY Holdings”), New Yarmouth Limited (“New Yarmouth”), Lascelles Limited (“Lascelles”), Tradewell Limited (“Tradewell”), C.P. Stephenson Limited (“Stephenson”), West Indies Metal Products Limited (“WI Metal”), Lascelles Laboratories Limited (“Lascelles Lab”), Lascelles Merchandise Limited (“Lascelles Merchandise”), Dr. Ian Sangster & Company Limited (Sangster”), Wray & Nephew Winery Limited (“Winery”) COMING UP FOR HEARING THIS DAY and upon hearing Mr. Jerome Spencer instructed by Patterson Mair Hamilton, Attorneys-at-Law for the Claimants/Applicants, **IT IS HEREBY ORDERED THAT:**

1. The Schemes of Arrangements set out in the attached Schedule are hereby sanctioned.
2. The Claimants (“the Scheme Companies”) undertake to be bound by the provisions of the sanctioned Schemes and to execute and do or procure to be executed all such documents, acts and things as may be necessary or desirable to be executed or done by any Scheme Company for the purpose of giving effect to any of the Schemes.
3. The parcels of land referred to in paragraphs 1.2, 3.2, 10.2,14.2, 15.2, 17.2, 18.2, 19.2, and 22.2 of the Schedule together with any other parcels of land not included in the Tables set out in the Schedule but which may be owned by any of the Scheme Companies or in which any of the Scheme Companies has an

interest (other than those parcels owned by JW&N) shall be transferred to JW&N subject to any mortgage, charge, caveat, easement, restrictive covenant, encumbrance or other right or interest vested in, or claimed by, any third party.

4. With respect to trademarks, (including the trademarks on the Trademark List in the Schedule attached hereto), copyrights, formulae, patents, designs (whether registered or un-registered) or other intellectual property rights, whether or not similar to any of the foregoing, they shall be transferred by universal succession from the present registered or un-registered holder to JW&N which shall be entitled to secure registration of all such trademarks, registered designs or other registered rights in its name or in the name of its nominee.
5. The issue of new JW&N shares to Campari Espana SL ("Campari") and/or its nominees as contemplated by that Scheme shall be subject to any prohibition or condition imposed by law. Without prejudice to the generality of the foregoing, if Campari and/or any nominee of Campari with a registered address in a jurisdiction outside Jamaica is advised that the issue of the new JW&N shares would or might infringe the laws of such jurisdiction or would or may require JW&N or LdM to observe or procure any governmental or other consent or make any registration, filing or other formality, with which JW&N or LdM is unable to comply or compliance with which JW&N or LdM, in its sole


discretion, regards as unduly onerous, JW&N or LdM, as the case may be, in its sole discretion, may determine that the relevant JW&N shares shall be issued to the Secretary of JW&N in trust for Campari and/ or its nominees and the issue of such JW&N shares shall operate as good discharge to JW&N. In the absence of bad faith or willful default neither JW&N nor LdM shall have any liability for any loss or damage arising as a result of any JW&N shares being so issued.

6. All deliveries of notices, share certificates, documents of title and the like required to be made under any of the Schemes shall be effected by personal delivery or delivery by pre-paid courier or by posting the same by registered post in prepaid envelopes addressed to the persons respectively entitled thereto at their respective addresses as appearing in the relevant register of members (or, in the case of joint holders, to the address of that one of the joint holders whose name stands first in the relevant register of members in respect of the joint holding) at the Scheme Record Time (as defined in the Scheme).
7. All cheques payable to the holders of preference shares as at the Scheme Record Time (as defined in the Scheme) shall be sent by post to such holders at the address appearing in JW&N's Register of Members. The sums payable in respect of cheques which are returned un-cashed or are not encashed (even though not returned), shall be held by JW&N in an interest-bearing trust account with a commercial bank for a period of six (6) years from which JW&N shall honour request for payment if, and when, made. After the expiration of the 6-year

period, the balance standing to the credit of such trust account shall be forfeited to JW&N to be held in trust to be applied for charitable purposes determined by the Board of Directors of JW&N.

8. No Scheme Company shall be responsible for any loss or delay in the transmission of any notices or documents posted in accordance with paragraph 6 above and all such notices or documents shall be posted at the risk of the persons entitled thereto.
9. On the Effective Date of the Scheme (as stated in paragraph 10 below) for a Scheme Company all certificates representing holdings of cancelled shares or stock units of such Scheme Company shall cease to have effect and every holder thereof shall be bound at the request of such Scheme Company to deliver up such stock or share certificate to such Scheme Company.
10. A Scheme in respect of a Scheme Company shall become effective as soon as an office copy of the Order under section 206(3) of the Companies Act, 2004 shall have been duly delivered by or on behalf of such Scheme Company to the Registrar of Companies in Jamaica for registration.

SCHEDULE

As respects Lascelles, deMercado & Company Limited ("LdM")

1.1 The stated capital of LdM shall be reduced by cancelling and extinguishing all the ordinary shares or stock units and all the preference shares or stock units (both the 6% and the 15% preference shares) except two such ordinary shares; namely one (1) registered in the name of Campari and the other registered in the name of Stefano Saccardi or Max Poliov to be held in trust for Campari.

1.2 The whole of the business of LdM, that is to say all the property, assets and rights of every description (whether real or personal, tangible or intangible) of LdM (herein called "Assets") (including without limitation the parcels of lands listed in the Table below) shall, by way of universal succession, be transferred to and be vested in JW&N and all the debts, liabilities and obligations of every description of LdM (including the capital reserve arising from the reduction of capital referred to in paragraph 3.3 above) (herein called "Liabilities") shall be transferred to and become debts, liabilities, obligations, capital reserves and other reserves (as applicable) of JW&N.

1.3 In consideration partly for the cancellation of the shares issued by LdM (being both the ordinary shares or stock units and the preference shares or units) and the transfer of LdM's Assets and Liabilities to JW&N, JW&N shall issue to the shareholders of LdM the shares referred to in paragraph 2.2 below to be distributed among them *pro rata* according to their existing shareholdings in LdM.

1.4 Contingently upon the matters referred to in paragraphs 1.2 and 1.3) above, LdM shall be automatically dissolved and struck off the Register of Companies without winding up pursuant to section 208 of the Companies Act, 2004 on the

date on which an attested copy of the Order is delivered to the Registrar of Companies for registration as respect LdM.

As respects J. Wray & Nephew Limited ("JW&N")

2.1 The share capital of JW&N shall be reduced by cancelling and extinguishing all the ordinary shares and preference shares issued by JW&N.

2.2 Simultaneously and contingently upon the reduction of capital referred to in paragraph 2.1 above taking effect:

- (a) the stated ordinary share capital of JW&N shall be increased to its amount before such reduction of capital by the creation of such number of ordinary shares as shall be equal to the number of ordinary shares cancelled pursuant to such reduction of capital;
- (b) JW&N shall apply the reserve arising as a result of such reduction of capital in paying up in full at par the new ordinary shares created pursuant to sub-paragraph (a) above and such new ordinary shares shall be allotted and issued credited as fully paid to Campari and/or its nominee(s) in part consideration for the cancellation of the shares issued by LdM and held by Campari as provided in paragraph 3.3 above and the transfer of the Assets and Liabilities of the members of the LdM Group (including LdM) as provided herein; and
- (c) in consideration for the cancellation of 6% cumulative preference shares, JW&N shall pay to the persons, who at the close of business at the Scheme Record Time were the registered holders of such shares the sum of J\$3.00 in respect of each such preference share plus dividend accrued up to the date of payment.

As respects Wray & Nephew Group ("JW&N")

3.1 The stated capital of W&N Group shall be reduced by cancelling and extinguishing all the shares issued by W&N Group except two ordinary shares; namely one registered in the name of LdM and the other in the name of C.P Stephenson Limited to be held in trust for W&N Group.

3.2 The whole of the business of W&N Group, that is all the property, assets and rights of every description (whether real or personal, tangible or intangible) of W&N Group (herein called "Assets") shall, by way of universal succession, be transferred to and be vested in JW&N and all the debts, liabilities and obligations of every description of W&N Group (including the capital reserve arising from the reduction of capital referred to in paragraph 3.1 above) (herein called "Liabilities") shall be transferred to and become debts, liabilities, obligations, capital reserves and other reserves (as applicable) of JW&N.

3.3 Contingently upon the matters referred to in paragraphs 3.1 and 3.2 above, W&N Group shall be automatically dissolved and struck off the Register of Companies without winding-up pursuant to section 208 of the Companies Act, 2004 on the date on which an attested copy of the Order is delivered to the Registrar of Companies for registration as respect W&N Group.

As respects Finzi & Company (Successors) Limited ("Daniel Finzi")

4.1 The share capital of Daniel Finzi shall be reduced by cancelling and extinguishing all the shares issued by Daniel Finzi except two ordinary shares; namely one registered in the name of JW&N and the other in the name of Jane George to be held in trust for JW&N.

4.2 The whole of the business of Daniel Finzi, that is all the property, assets and rights of every description (whether real or personal, tangible or intangible) of Daniel Finzi (herein called "Assets") shall, by way of universal succession, be transferred to and be vested in JW&N and all the debts, liabilities and obligations of every description of Daniel Finzi (including the capital reserve arising from the reduction of capital referred to in paragraph 4.1 above) (herein called "Liabilities") shall be transferred to and become debts, liabilities, obligations, capital reserves and other reserves (as applicable) of JW&N.

4.3 Contingently upon the matters referred to in paragraphs 4.1 and 4.2 above, Daniel Finzi shall be automatically dissolved and struck off the Register of Companies without winding-up pursuant to section 208 of the Companies Act, 2004 on the date on which an attested copy of the Order is delivered to the Registrar of Companies for registration as respect Daniel Finzi.

As respects Edwin Charley Limited (“Edwin Charley”)

5.1 The share capital of Edwin Charley shall be reduced by cancelling and extinguishing all the shares issued by Edwin Charley except two ordinary shares; namely one registered in the name of W&N Group and the other in the name of Jane George to be held in trust for W&N Group.

5.2 The whole of the business of Edwin Charley, that is all the property, assets and rights of every description (whether real or personal, tangible or intangible) of Edwin Charley (herein called “Assets”) shall, by way of universal succession, be transferred to and be vested in JW&N and all the debts, liabilities and obligations of every description of Edwin Charley (including the capital reserve arising from the reduction of capital referred to in paragraph 5.1 above) (herein called “Liabilities”) shall be transferred to and become debts, liabilities, obligations, capital reserves and other reserves (as applicable) of JW&N.

6.1 The share capital of Sugar Mills shall be reduced by cancelling and extinguishing all the shares issued by Sugar Mills except two ordinary shares; namely one registered in the name of W&N Group and the other in the name of Jane George to be held in trust for W&N Group.

6.2 The whole of the business of Sugar Mills, that is all the property, assets and rights of every description (whether real or personal, tangible or intangible) of Sugar Mills (herein called “Assets”) shall, by way of universal succession, be transferred to and vested in JW&N and all the debts, liabilities and obligations of every description of Sugar Mills (including the capital reserve arising from the reduction of capital referred to in paragraph 6.1 above) (herein called “Liabilities”) shall be transferred to and become debts, liabilities, obligations, capital reserves and other reserves (as applicable) of JW&N.

6.3 Simultaneously, and contingently upon the matters referred to in paragraphs 6.1 and 6.2 above, Sugar Mills shall be automatically dissolved and struck off the Register of Companies without winding-up pursuant to section 208 of the Companies Act, 2004 on the date on which an attested copy of the Order is delivered to the Registrar of Companies for registration as respect Sugar Mills.

As respects The Rum Company (Jamaica) Limited (“Rum Company”)

7.1 The share capital of Rum Company shall be reduced by cancelling and extinguishing all the shares issued by Rum Company except two ordinary shares; namely one registered in the name of W&N Group and the other in the name of Jane George to be held in trust for W&N Group.

7.2 The whole of the business of Rum Company, that is all the property, assets and rights of every description (whether real or personal, tangible or intangible) of Rum Company (herein called “Assets”) shall, by way of universal succession, be transferred to and vested in JW&N and all the debts, liabilities and obligations of every description of Rum Company (including the capital reserve arising from the reduction of capital referred to in paragraph 9.4 above) (herein called “Liabilities”) shall be transferred to and become debts, liabilities, obligations, capital reserves and other reserves (as applicable) of JW&N.

7.3 Simultaneously, and contingently upon the matters referred to in paragraphs 7.1 and 7.2 above, Rum Company shall be automatically dissolved and struck off the Register of Companies without winding-up pursuant to section 208 of the Companies Act, 2004 on the date on which an attested copy of the Order is delivered to the Registrar of Companies for registration as respect Rum Company.

As respects Appleton Estate Limited (“Appleton Estate”)

8.2 The whole of the business of Appleton Estate that is all the property, assets and rights of every description (whether real or personal, tangible or intangible) of Appleton Estate (herein called “Assets”) shall, by way of universal succession, be transferred to and be vested in JW&N and all the debts, liabilities and obligations

of every description of Appleton Estate (including the capital reserve arising from the reduction of capital referred to in paragraph 8.1 above) (herein called "Liabilities") shall be transferred to and become debts, liabilities, obligations, capital reserves and other reserves (as applicable) of JW&N.
