WHEREAS, the mark Equi-Pro is registered with the United States Patent and Trademark Office having Registration Number 3,047,596 dated January 24, 2006 (Serial Number 76587116), and with the Illinois Secretary of State as Registration Number 092273 dated May 13, 2004;

WHEREAS, Oak Services II, LLC, an Illinois limited liability company ("Oak LLC"), of 333 E. Butterfield Road, Suite 820, Lombard, IL 60148, is merging with Oak Corp such that Oak Corp shall be merged into Oak LLC, with Oak LLC being the surviving entity; and

WHEREAS, by operation of law and as part of the agreements entered into by and between Oak Corp and Oak LLC as it pertains to the merger of these entities, Oak LLC shall be the owner of all of Oak Corp's right title and interest in and to the assets of Oak Corp, including but not limited to, the Trademarks;

NOW, THEREFORE, and for good and valuable consideration, receipt of which is hereby acknowledged, the parties agree that upon the consummation of the merger, Oak Corp's ownership of the Trademarks shall be transferred to Oak LLC;

The parties agree that this Acknowledgement document does not, and is not intended to, change any other agreements, rights or obligations of the parties, but is done for purposes of

providing separate documentation evidencing that all right, title and interest in and to the Trademarks is vested in Oak LLC.

Oak Corp does hereby convey, assign and transfer to Oak LLC all right, title and interest in and to the Trademarks, together with the good will of the business symbolized by the Trademarks and the above identified registrations thereof.

Lillig to file such assignments on the appropriate records of the US Patent and Trademark Office and the State of Illinois, all as may be necessary and appropriate to record the assignment of the trademarks as indicated herein.

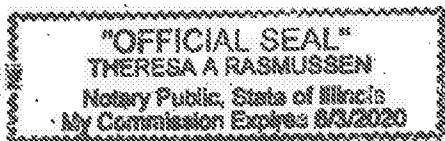
