RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release") may be filed with the United States Patent and Trademark Office to evidence Agent's release of the security interest against such trademarks.

This Release is intended to operate as a release of all liens and security interests conveyed by Grantor to Agent pursuant to the terms of the Trademark Agreement described above, without any representation, warranty or undertaking by, or recourse to, Agent. If and to the extent Agent has acquired any right, title or interest in and to any of the Trademark Collateral pursuant to the terms of the Trademark Agreement, Agent hereby reassigns and transfers such right, title and interest to Grantor, without any representation, warranty or undertaking by, or recourse to, Agent.
