**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

If and to the extent Agent has acquired any right, title or interest in and to any of the Trademark Collateral pursuant to the terms of the Trademark Agreement, Agent hereby reassigns and transfers such right, title and interest to Grantor, without any representation, warranty or undertaking by, or recourse to, Agent.
