7. SOHMER, China Registration No. 3426732;
8. SOHMER & CO., China Registration No. 11714749;
9. SOHMER, South Korean Registration No. 579123;
10. SOHMER, Indonesian Registration No. 559709.  
(collectively referred to herein as the "Asian Registrations")

WHEREAS, Persis International, Inc., a Michigan, USA Corporation with a place of business at 3323 W. Addison St. #B-2 Chicago, IL 60618 ("Assignee") wishes to acquire all of Assignor's worldwide right, title, and interest in and to the SOHMER, SOHMER & CO., and BUSH & GERTS trademarks, including all of its existing right, title, and interest in and to the ten (10) properties listed above together with all of its common law rights therein and all of its goodwill appurtenant thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor agrees as follows:

- A. Assignor hereby assigns and transfers to Assignee all of its worldwide right, title and interest in and to the SOHMER, SOHMER & CO., and BUSH & GERTS trademarks, including without limitation: (i) the United States Registration, (ii) the Expired United States Registrations, (iii) the Pending United States Application, (iv) the Asian Registrations, (v) all of Assignor's common law, state, federal, and national rights therein, including the goodwill of the business symbolized thereby as well as all other rights, if any, which Assignor may have in the words SOHMER, SOHMER & CO., and BUSH & GERTS alone or in connection with other words or designs, as a trade name, trademark or service mark.
- B. Assignor hereby warrants and represents that:

1. It has the right to transfer its rights in the SOHMER, SOHMER & CO., and BUSH & GERTS trademarks, the United States Registration, the Expired United States Registrations, the Pending United States Application, and the Asian Registrations, including without limitation all of its common law, state, federal and national rights therein together with all of its goodwill appurtenant thereto, to Assignee; and
2. It has not assigned or licensed any of its rights in the SOHMER, SOHMER & CO., and BUSH & GERTS trademarks to any other person or entity.
3. This Assignment cannot be terminated or amended, except by the written agreement of Assignee.
4. This Agreement shall be binding on assignor, as well as its successors and assigns, and shall inure to the sole and exclusive benefit of Assignee, its successors and assigns, and its present and future affiliated and subsidiary companies and licensees.
