**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL, dated June 30, 2016 (the “Release”), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION (as successor by assignment to General Electric Capital Corporation), as agent (in such capacity, “Agent”), in favor of SPRINGS WINDOW FASHIONS, LLC, a Delaware limited liability company (“Springs Window Fashions”), HORIZONS HOLDINGS, LLC, a Delaware limited liability company (“Horizons Holdings”), MECHOSHADE SYSTEMS, INC., a New York corporation (“Mechoshade Systems”), and SUNSETTER PRODUCTS LIMITED PARTNERSHIP, a Massachusetts limited partnership (“Sunsetter Products”, and together with Springs Window Fashions, Horizons Holdings, and Mechoshade Systems, each individually a “Grantor” and collectively the “Grantors”). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Credit Agreement and the Guaranty and Security Agreement (referred to below).

WHEREAS, the Grantors and Agent are parties to that certain Credit Agreement dated as of June 4, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) and that certain Guaranty and Security Agreement dated as of June 4, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”);

WHEREAS, pursuant to the Guaranty and Security Agreement, (i) Springs Window Fashions executed the Trademark Security Agreement dated June 4, 2013 and recorded with the U.S. Patent and Trademark Office (“USPTO”) on June 4, 2013 at Reel/Frame No. 5040/0689, the Patent Security Agreement dated June 4, 2013 and recorded with the USPTO on June 4, 2013 at Reel/Frame No. 30555/0046, and the Copyright Security Agreement dated June 4, 2013 and recorded with the U.S. Copyright Office (“USCO”) on June 10, 2013 at V3632 D452 (collectively, the “June 2013 IP Security Agreements”), (ii) Horizons Holdings executed the Trademark Security Agreement dated February 7, 2014 and recorded with the USPTO on February 7, 2014 at Reel/Frame No. 5211/0862, the Patent Security Agreement dated February 7, 2014 and recorded with the USPTO on February 7, 2014 at Reel/Frame No. 32170/0751, and the Copyright Security Agreement dated February 7, 2014 and recorded with the USCO on February 12, 2014 at V9909 D151 (collectively, the “February 2014 IP Security Agreements”), (iii) Mechoshade Systems executed the Trademark Security Agreement dated May 26, 2015 and recorded with the USPTO on May 28, 2015 at Reel/Frame No. 5524/0922, the Patent Security Agreement dated May 26, 2015 and recorded with the USPTO on May 28, 2015 at Reel/Frame No. 35735/0943, and the Copyright Security Agreement dated May 26, 2015 and recorded with the USCO on May 29, 2015 at V9906 D187 (collectively, the “May 2015 IP Security Agreements”), and (iv) Sunsetter Products executed the Trademark Security Agreement dated April 5, 2016 and recorded with the USPTO on April 6, 2016 at Reel/Frame No. 5766/0856 and the Patent Security Agreement dated April 5, 2016 and recorded with the USPTO on April 6, 2016 at Reel/Frame No. 38369/0574 (collectively, the “April 2016 IP Security Agreements,” and together with the June 2013 IP Security Agreements, the February 2014 IP Security Agreements, and the May 2015 IP Security Agreements, each individually an “IP Security Agreement” and collectively the “IP Security Agreements”), pursuant to which the Grantors granted to the Agent a Lien on and security interest in, all of Grantors’ right, title and interest in, to and under the Trademark Collateral, Patent Collateral, and Copyright Collateral (as defined in the IP Security Agreements);

WHEREAS, in connection with the repayment of all Indebtedness and the termination of all Revolving Loan Commitments under the Credit Agreement, and the release of security interests under the Loan Documents, each Grantor has informed the Agent of its desire to obtain the release of all right, title and interest of the Agent, for the benefit of Secured Parties and each other grantee or beneficiary, in and to the Trademark Collateral, Patent Collateral, and Copyright Collateral granted under the IP Security Agreements.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby release, cancel, relinquish and discharge any and all security interests it has against the Trademark Collateral, Patent Collateral, and Copyright Collateral and reassigns all right, title and interest it has in the Trademark Collateral, Patent Collateral, and Copyright Collateral to the applicable Grantor, including without limitation the Trademark Collateral, Patent Collateral, and Copyright Collateral listed on Schedule A attached hereto and incorporated herein by reference. The Agent agrees, or authorizes the Grantors (or their respective designees), to make filings with the USCO and USPTO and take further actions, in each case as reasonably requested by the Grantors and at the sole expense of the Grantors, to evidence the release and termination of the Agent's security interests in the Trademark Collateral, Patent Collateral, and Copyright Collateral. The execution and delivery of this release and any further documents and the performance of any actions by the Agent are made without representation or warranty by, or recourse to, the Agent or any other Secured Party.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTORS' AND THE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
