3. Assignee hereby assumes and agrees to perform all remaining and obligations of Assignor related to the Mark and agrees to indemnify and hold Assignor harmless from any claim or demand resulting from non-performance by Assignee;
4. Assignor and Client warrant and represent that the Mark is in full force and effect and is fully assignable. Assignor further warrants that it has the full right and authority to transfer the Mark and that the Agreement rights herein transferred are free of lien, encumbrance or adverse claim.


