- 1. Guggenheim hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the IP Collateral, whether granted pursuant to the Security Agreement, IP Security Agreement or any other agreement or document delivered in connection therewith.

- 3. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.


