**CONFIRMATION OF  
TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

June 24, 2016

WHEREAS, **VRIDE, INC.**, a Delaware corporation (formerly known as **VPSI, INC.**) (the "**Grantor**"), entered into that certain **Trademark Security Agreement** dated as of December 23, 2010 (the "**Trademark Security Agreement**"), among the Grantor and **PROSPECT CAPITAL CORPORATION**, in its capacity as **Administrative Agent** (in such capacity, the "**Administrative Agent**"), pursuant to that certain **Credit Agreement**, dated as of December 23, 2010 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the "**Credit Agreement**"), by and among the Grantor, certain of the Grantor's affiliates party thereto from time to time, the **Administrative Agent** and certain lenders party thereto, a true and correct copy of said **Trademark Security Agreement** having been recorded with the United States Patent and Trademark Office on December 23, 2010, at Reel 004440, Frame 0217; and

WHEREAS, by that certain **Termination Agreement** dated as of March 16, 2012 (the "**Termination Agreement**") by and among the Grantor, certain of the Grantor's affiliates party thereto, the **Administrative Agent** and certain lenders party thereto, the **Administrative Agent** released, discharged fully and reassigned to the Grantor the **Administrative Agent's security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademark Collateral**, including, but not limited to, those **Trademarks** identified on Exhibit A hereto and made a part hereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the **Administrative Agent** hereby:

1. confirms that the **Trademark Security Agreement** was terminated on the date of the **Termination Agreement** and that, on such date, the **Administrative Agent** released, discharged fully and reassigned to the Grantor any and all liens and security interests of the **Administrative Agent** in, to and under the **Trademark Collateral**, whether then owned or existing or at any time thereafter acquired or arising and wherever located, including, but not limited to, the **Trademarks** identified on Exhibit A hereto;
2. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release thereby given; and
3. agrees that it shall, at the **Grantor's, or its successor's or assign's**, reasonable request, execute, acknowledge and deliver to the Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

Capitalized terms not defined herein shall have the meanings ascribed to such terms in the **Trademark Security Agreement**.

THIS CONFIRMATION OF TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS CONFIRMATION OF TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.


