SENIOR NOTES IP SECURITY AGREEMENT SUPPLEMENT

This SENIOR NOTES IP SECURITY AGREEMENT SUPPLEMENT, dated June 27, 2016 (this "Supplement"), is delivered pursuant to the Senior Notes Intellectual Property Security Agreement, dated as of June 26, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), among Cenveo, Inc., a Colorado corporation ("Holdings"), Cenveo Corporation, a Delaware corporation (the "Issuer"), each other Subsidiary (such term and the other capitalized terms used and not defined in this Supplement have the meanings assigned thereto in the IP Security Agreement) of Holdings from time to time party thereto (Holdings, the Issuer and such Subsidiaries, each a Grantor" and, collectively, the "Grantors") and The Bank of New York Mellon, as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties.

WHEREAS, each Grantor and the Collateral Agent have authorized Holdings to supplement the scheduled information with respect to such Grantor set forth in the IP Security Agreement from time to time as required by the Security Agreement.

Holdings, on its own behalf and on behalf of each other Grantor, hereby certifies to the Collateral Agent and each other Secured Party that, as of the date hereof, each of the Schedules to the IP Security Agreement are hereby supplemented and amended by the additions set forth on the schedules hereto; provided, that no such supplement or amendment shall release or be deemed to release any security interest in any Collateral granted to the Collateral Agent and the Secured Parties pursuant to the IP Security Agreement.

Holdings, on its own behalf and on behalf of each other Grantor, hereby covenants and agrees to enter into each other instrument as the Collateral Agent deems necessary and proper to perfect its security interest in the Intellectual Property described herein.
