ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States, as well as any official of any countries or international entities foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Mark and title thereto as the property of ASSIGNEE, its successors and assigns, in accordance with the terms of the aforementioned.
