## ASSIGNMENT OF SECURITY INTEREST

6/28/2016

THIS ASSIGNMENT OF SECURITY INTEREST (this "Assignment"), dated as of \_\_\_\_\_, is executed by Arctaris Royalty Ventures Co-Investment Limited Partnership, a Massachusetts limited partnership ("**Assignor**"), in favor of F. Mitchell Thrower III, as Collateral Agent ("**Assignee**"). All capitalized terms used in this Assignment and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

### RECITALS

A. Pursuant to that certain Security Agreement, dated as of December 17, 2014, (the "**Security Agreement**"), executed by Bump Network (d/b/a Events.com), a California corporation ("**Bump**"), Global Event Data, Inc. (f/k/a Gablit LLC), a Delaware corporation ("**Gablit**"), PixelPushers, Inc. (d/b/a Civica), a California corporation ("**Civica**"), and Events.com LLC, a Delaware limited liability company ("**Events.com**" and, together with Bump, Civica and Gablit, individually and collectively, jointly and severally, the "**Debtor**") in favor of Assignor, Debtor granted to Assignor a security interest in the IP Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on December 22, 2014, at Reel/Frame 5424/0912, to evidence the security interest granted under the Security Agreement.

C. The Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on December 22, 2014, at Reel/Frame 034567/0916, to evidence the security interest granted under the Security Agreement.

D. Thereafter, Assignor has entered into a Settlement Agreement, dated as of June 28, 2016 (as amended, restated or otherwise modified from time to time, the "**Settlement Agreement**"), with Debtor.

E. Pursuant to the Settlement Agreement, Assignor has irrevocably assigned to Assignee, subject to and in accordance with the terms and conditions as set forth in the Settlement Agreement, all of Assignor's rights and obligations in its capacity as a secured party under the Security Agreement.

F. Assignor agrees to execute this Assignment in order to evidence the assignment of its security interest in the Security Agreement specified below to Assignee.

### AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows:

- (a) Assignor expressly assigns to Assignee, all of Assignor's right, title and interest in, to and under the Security Agreement (collectively, the "IP Collateral"), as set forth on Schedule 1.
- (b) Assignor represents and warrants that it has the full power and authority to execute this Assignment.
- (c) Assignor authorizes and requests the Trademark and Patent Divisions of the United States Patent and Trademark Office to record this Assignment.
