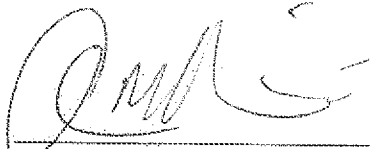
(2) The Certificate of Incorporation is hereby amended by striking out Article First thereof and by substituting in lieu of said Article First the following new Article First:
