## RELEASE OF SECURITY INTEREST

This Release of Security Interest Agreement (this "Release"), dated as of June 29, 2016, is made by Metro Phoenix Bank (the "Lender"), whose mailing address is 4686 E. Van Buren, Phoenix, AZ 85008, in favor of Wellements, LLC and Detoxify, LLC (collectively, the "Company"), each an Arizona limited liability company, with their chief executive offices located at 8901 East Pima Center Parkway, Suite 215, Scottsdale, AZ 85258. The company and the Lender are each a "Party" and are collectively the "Parties."

### RECITALS

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated November 14<sup>th</sup>, 2013, between Lender and the Company (the "Security Agreement"), the Company pledged and granted a security interest certain trademarks described in the Security Agreement to Lender.

**WHEREAS**, the Security Agreement inadvertently included a grant of security interest in two trademarks (the "Trademarks"), described on Exhibit A attached hereto, that the Company did not wish to pledge and that the Lender did not intend to receive.

**WHEREAS**, the Company now desires to restore the original intention of the Security Agreement and has requested that the Lender release its security interest in the Trademarks inadvertently pledged pursuant to the Security Agreement.

Now, therefore, in consideration of the foregoing and other mutual benefits accruing to the parties hereto, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:


1. **Release of Security Interest.** The Lender hereby releases the Company, without covenant or warranty, express or implied, from any and all of its obligations under the Security Agreement with respect to the Trademarks, including those provisions, which by their terms, survive the release of the Company from such obligations under the Security Agreement. The corrected schedule of trademarks that should have been attached to the Security Agreement is set forth on Exhibit B.
2. **Acknowledgment of Inadvertent Inclusion.** The grant of security interest in the Trademarks in the Security Agreement was inadvertent and the Company did not wish to pledge such interest in the Trademarks nor did the Lender intend to receive such interest. In acknowledgment of this fact, the Parties agree that the provisions and obligations of the Security Agreement with respect to the Trademarks are void.
3. **Amendment of Recordation Documents.** The Lender agrees that, upon execution of this Release, the security interest in the Trademarks shall be deemed void and is hereby terminated and the Lender will file (and the Company is authorized to file) amendments or any other required documents with the United States Patent and Trademark Office to delete the Trademarks from the descriptions of the collateral in the statements filed on behalf of the Lender and to effect the release of the lien and security interest of the Lender in the Trademarks evidenced by the statements.
4. **Miscellaneous.**
  - (a) **Finance Documents Remain In Effect.** Except as expressly provided in this Release, the execution of this Release shall in no manner affect the duties, obligations or liabilities of the Company with respect to or under the Security Agreement.
  - (b) **Governing Law.** This Release, including all matters of construction, validity and performance, shall be governed by the laws of the State of Arizona without regard to the conflict of laws rules thereof, except as may be required by other mandatory provisions of applicable law.

(c) Counterparts. This Release may be executed in any number of counterparts and by the different parties hereto on separate counterparts, each of which when so executed and delivered shall be an original, but all of which shall together constitute one and the same instrument.


(d) Successors and Assigns. This Release shall be binding upon and inure to the benefit of and be enforceable by the respective successors and permitted assigns of the parties hereto.
